- Wait 3 years (from date of non-resident Tax status, only applicable if ceased to be a tax resident from 1 March 2021)

- Apply for SARS AIT clearance
- Encash retirement/investments funds 3yrs rule apply
- Always ensure Tax compliance

- 2 Moved abroad within 3 years
